Hazardville Water Customers:

On March 23, 2023, the Public Utilities Regulatory Authority(PURA) approved a 2022 Revenue Adjustment Mechanism (RAM) surcharge of 6.57% effective April 1, 2023 on a bills rendered basis. On March 29, 2023 PURA approved a 0.37% WICA reconciliation surcharge, effective April 1, 2023 on a bills rendered basis. This brings the WICA surcharge to 7.92%.
